## Sungard – eFinancePLUS

Representatives from Sungard came out to West Clermont on Tuesday, May 3<sup>rd</sup> to demonstrate the eFinancePLUS software. West Clermont staff and fiscal staff from several other districts attended and we've received a lot of good feedback about the product.

The deadline for applying for the first wave of implementations has been extended to next Friday, May 13<sup>th</sup>. The first wave will begin on July 1<sup>st</sup> with a target golive date of January 1<sup>st</sup>, 2017. #### **Five Year Forecast Info**

Five Year Forecast is a financial projection which consists of three years of historical data, projections for the current year and four ensuing years, the ADM forecast, and a summary of key assumptions. Data is required to be reported in EMIS by all city, exempted village, local, and joint vocational school districts.

The required Spring Update submission of this data is due by May 31<sup>st</sup> of each year. District QF and QN records are submitted via the EMIS Data Collector. If districts wish to also send district notes in PDF format, they should be emailed
